

The development

Comprises: 441 homes in total 197 affordable 244 private 8 blocks 6-13 storeys







What have we been doing since we last met?

Throughout 2022 we have been working on:

- Detailed design for the first block (block A)
- Pre-start on site planning conditions
- Service connection diversion telecoms and gas
- A temporary car parking solution for disabled residents and CPZ permits for other car users
- Construction details and logistics.

Early works

January 2023

- Create residents' disabled parking spaces
- Notices served for vehicles to leave Geoffrey Close on 16th January
- Geoffrey Close vehicle access will be closed 23th January
- Create temporary storage compound area
- Break down concrete bollards
 on site
- Vacate pram sheds
- Demolish pram sheds
- Relocate bin store

February 2023

 Erect site wide hoarding and commence enabling works

Phase One

Block A construction

Block A will be constructed first, in the Kenbury Street side of the site.

Block A comprises 25 new homes, six storeys high.

Phase One

January / February 2023


Geoffrey Close will be closed off and all internal estate parking suspended.

Hoarding will be erected and traffic marshals employed to:

- Secure the area
- Manage health & safety
- Manage construction traffic.

Bellway & Riverside will make arrangements to ensure that refuse collections and emergency vehicles can still access the site when necessary.

Residents will still be able to use the footpaths on and around the estate to access their homes and gardens.


Hoarding & screening

Down lighting will be along the hoarding line









Delivery times


Monday - Friday: 09:00 – 15:00 & 16:00 – 16:30 (Term time)

- Best endeavours will be made to minimise noise and disturbance

Recycling

 A Site Waste Management Plan (SWMP) will be developed and will be used on this project. We will segregate waste where possible



Temporary car parking on Lilford Road Geoffrey Close closure, all vehicle access suspended Hoarding erected throughout the site Site access to construction and emergency vehicles only Clear Block A site area

February 2023 - Winter 2024/2025

Construction of Block A Handover to Riverside First 25 households moving into their new homes

Demolish 1-28 York Close & 1-16 Geoffrey Close



- We will compensate you at least £7,800 for moving, plus disturbance payment
- We will provide a removal service for all and packing and wrapping service for those who need it.




